6 AUGUST 2021 – SHIP ARRIVES IN REYKJAVIK, ICELAND: *Five day port call.

Disembarking staff/science party should not schedule return flights before 0600 on 07 OCTOBER 2021.
STANDARD RETURN DATE: If vaccinated: 07 October - If not vaccinated: 08 October (pending COVID test results)

GROUND TRANSPORTATION: Unless instructed otherwise, taxis should be used for transportation between the airport and hotel before and after the expedition. Buses or vans will be used between the hotel and ship as the Port Agent must escort all personnel from the ship to the hotel.
